As a Daniel K. Inouye International Airport (HNL) Motor Vehicle Movement Operator's Permit (M License) holder, I acknowledge, understand, and hereby agree to the following requirements:

- 1) Receive recurrent Movement Area Driver's Training on or before my permit expires.
- 2) Return the Movement Permit to the Pass & ID Office if I do not receive recurrent training by permit expiration date or when it is no longer a requirement of my job to operate in the Movement Area.
- 3) Immediately surrender the M License to the Pass & ID Office, my Supervisor, and/or the company's Authorized Signatory if my driver's license becomes invalid, for any reason.
- 4) Immediately surrender the permit upon request by Airport Operations personnel, Airport Security, and/or Airport Police services. Failure to do so may result in criminal charges against me.
- 5) Immediately notify the Pass & ID Office, my supervisor and/or the company's Authorized Signatory if my Movement Permit is lost, stolen, or unaccounted for.
- 6) If I hold a Movement Permit for more than one company, I will only use the permit that is consistent with the badge used to access Airport property.
- 7) I am not allowed to drive in the Movement Area without a current and valid Movement permit.
- 8) I agree to all fees associated with the Movement permit.
- 9) Failure of any of the above may result in the deactivation of my HNL badge until the requirements are met.
- 10) I have received training administered by my company/organization pertaining to airfield familiarity and radio operations.
- 11) I agree to abide by the rules and regulations prescribed for the operation of any equipment within the airport movement area. Use of this permit in any manner or method which violates the airport, state, and/or federal rules and regulations may result in one or more of the following: administrative action, retraining, monetary fines against me personally or the company for which I represent, and/or revocation of all driving privileges at HNL.
