#### **BLUETOOTH (BT) ACCESS AGREEMENT TERMS AND CONDITIONS**

As a Daniel K. Inouye International Airport (HNL) BT access holder, I acknowledge and hereby agree to the following requirements, terms, and conditions on behalf of my employer and/or company (which includes organizations, agencies, Tenants, Private Plane Owners, and Lessees at HNL) that I represent:

The commission of any of the following acts is reason for immediate confiscation, suspension, and/or revocation (temporary or permanent) of the Airport ID Media Badge and BT access, issuance of a Violation Notice and the requirement to meet with the Airport Security Coordinator:

- 1. Bluetooth access must be treated like any other access control device.
- 2. Badge-holders with BT access are not allowed to bypass the security system by passing back or loaning anyone their mobile device to use the BT access. This will be considered the same as loaning your Airport ID Badge and will result in Airport ID Badge confiscation and the termination of Bluetooth access.
- 3. No piggybacking through a BT **DOOR** is allowed. All badged individuals must be assigned BT access and follow escort procedures for those unbadged individuals that require door access.
- 4. All individuals controlling a BT **PADLOCK** gate must verify all individuals requiring unescorted access by comparing to the HNL-issued Stop List and follow proper escort procedures for unbadged individuals.

I, as the BT access holder, will always keep the BT access on my mobile device secured and protected with passcode or biometric to open device and will not allow anyone to use the BT access on my mobile device.

I understand that I, as a BT access holder, and my employer/company may be subject to fees and/or civil penalties for not properly controlling my BT access and allowing anyone else to access a BT door/gate with my BT access mobile device.

Lost and/or stolen mobile devices must be reported IMMEDIATELY so that BT access can be revoked.

- 1. Email <a href="mailto:dot.air.hnl.south.ramp@hawaii.gov">dot.air.hnl.south.ramp@hawaii.gov</a> BT access will be removed from the BT lock, until a new Bluetooth Access Application is submitted with the new Airport ID Badge number.
- 2. A report must be filed with the Police or Sheriff.

Any BT access issued to me is for Official Business Use Only. I will use the BT access for work related purposes only, as authorized by my employer/company. I will not use the BT access without a valid operational need.

My BT access usage is limited to my work hours.
